Information on European Personal Data Protection Regulation ex-art.# 13-14 to EU 2016/679

Nautica Imperia Services SRL informs you that, in accordance to European law# UE2016/679 "GDPR", the aforementioned legislation provides the protection of your data regarding the processing of your personal details and that this treatment will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Your personal data will be processed in accordance with the legislative provisions of the aforementioned law and the confidentiality obligations laid down therein.

Processing Purposes: in particular, your data will be processed for the following purposes related to the implementation of the fulfilment of legislative or contractual obligations:

- obligations required by law in the field of taxation and accounting
- litigation management

The processing of functional data for the fulfilment of these obligations is necessary for a proper management of the relationship and their provision is mandatory for achieving the above purposes.

Your data will also be processed for the following purposes related to contractual or pre-contractual obligations:

Retention Period. Please note that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 of the GDPR, the retention period of your personal data is:

- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed for the execution and completion of the contractual purposes.
- established for a period of time not exceeding the completion of the services provided.
- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the mandatory time limits prescribed by law.

The subject to whom data is related , has the right , to stop the processing of the personal data and furthermore may oppose treatment for legitimate reasons at any time as well as in general you can exercise all the rights foreseen by the GDPR art. # 15,16,17,18,19,20,21,22.

EU regulations 2016/679 art # 15,16,17,18,19,20,21,22 – Rights of the subject

1. Data Subject shall have the right to obtain confirmation of the existence or not of personal data concerning him/her, even if not yet registered, and their communication in intelligible form.

2. Data Subject shall have the right to obtain indication of:

- a. the origin of personal data;
- b. the purposes and processing methods;
- c. the logic applied in case of processing carried out with the use of electronic instruments;
- d. the identifying details of the owner, of the responsible and of the designated representative according to article 5, paragraph 2;
- e. the subjects or categories of subjects to whom the personal data may be communicated or who might learn about them as appointed representative over the State territory, other people in charge.

3. Data Subject shall have the right to obtain:

- a. the updating, correction or, when interested, integration of data;
- b. the cancellation, the transformation into anonymous form or the blocking of data processed in violation of the law, including those that do not need to be kept for the purposes for which data were collected or subsequently processed;
- c. the attestation that the operations referred to in letters a) and b) have been brought to the knowledge, also with regard to their content, of those to whom data have been communicated or disseminated, except in the case in which this fulfilment proves impossible or involves a use of means manifestly disproportionate to the protected right;
- d. data portability.

4. Data Subject shall have the right to object, in whole or in part:

- a. for legitimate reasons, the processing of personal data concerning him/her, even if pertinent to the purpose of the collection;
- b. the processing of personal data concerning him/her for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
